2026 SMS/Text Messaging Consent Policy

1. Overview

Slow Moving Fitz Jr. LLC (“SMF, JR.,” “we,” “our,” or “us”) may send service-related text messages to individuals who voluntarily provide their mobile phone number and give express consent to receive such communications. This policy explains how subscribers opt in, what types of messages they may receive, how to opt out, and how we handle related data.

This SMS/Text Messaging Consent Policy applies to all text communications sent by Slow Moving Fitz Jr. LLC

2. Types of Messages You May Receive

By opting in, you agree to receive service-related, non-marketing text messages, which may include:

- Responses to your contact inquiries
- Service updates or status notifications
- Appointment or meeting notifications
- Confirmations or follow-up messages
- Support communications
- Other operational or transactional messages related to your interaction with Slow Moving Fitz Jr. LLC

Slow Moving Fitz Jr. LLC, does not send promotional or marketing text campaigns. Slow Moving Fitz Jr. LLC, does not use automated dialing systems or send telemarketing messages.

3. How You Provide Consent (Opt-In Process)

You may opt in to receive text messages from Slow Moving Fitz Jr. LLC by:



- Providing your mobile number through a Slow Moving Fitz Jr. LLC form, intake process, or digital submission
- Checking a consent box acknowledging that you agree to receive text messages
- Submitting the form, which records your consent

In some cases, Slow Moving Fitz Jr. LLC may use a double opt-in process, where you confirm your consent by replying “YES” to an initial confirmation message.

Providing your mobile number alone does not constitute consent; you must also acknowledge the consent statement presented at the time of submission.

4. Message Frequency and Costs

Message frequency varies based on your interactions with Slow Moving Fitz Jr. LLC. Standard message and data rates may apply, depending on your mobile carrier plan.

Slow Moving Fitz Jr. LLC is not responsible for any charges imposed by your carrier.

5. How to Opt Out

You may opt out of receiving text messages at any time by replying:

STOP

After you send STOP, you will receive a confirmation message, and no further text messages will be sent unless you opt in again.

6. How to Request Help

If you need assistance related to text messages, reply:

HELP

7. Data Privacy and Security

Your mobile number and any related information collected for SMS communications are handled in accordance with Slow Moving Fitz Jr. LLC's Privacy Policy.

We do not sell, rent, or share your mobile number with third parties for marketing purposes.

We may share your information with service providers who assist in delivering text messages, but only as necessary to perform those services and in compliance with applicable privacy laws.

8. Eligibility and User Responsibilities

By opting in, you confirm that:

- You are the owner or authorized user of the mobile number provided
- You are at least 18 years old
- You understand that consent is not a condition of receiving services from Slow Moving Fitz Jr. LLC

You agree to notify Slow Moving Fitz Jr. LLC if your mobile number changes or is reassigned.

9. Changes to This Policy

Slow Moving Fitz Jr. LLC may update or modify this SMS/Text Messaging Consent Policy at any time. Any changes will be posted on our website with an updated "Last Updated" date.

Your continued use of our services after changes are posted constitutes acceptance of the revised policy.
